
1. Carefully tear off foil pack, making sure not to damage the condom.








Remove the wings from the condom by turning them away from the body at the point where the wings join. The condom is now ready for use.







- Stop and check if the condom slipping off or tightening excessively onto the penis as this might lead to breakage.
- 7. Soon after ejaculation, and while the penis is still erect, hold the condom at the base of the penis and withdraw carefully.
- 8. Remove the condom from your penis by sliding it off slowly. It is important not to permit the penis or used condom to touch the vagina area after withdrawal.
